ORDINANCE NO. 2009-12

**A BILL TO BE ENTITLED**

**AN ORDINANCE AMENDING THE OPERATING BUDGET FOR THE CITY OF NEPTUNE BEACH, FLORIDA FOR FISCAL YEAR 2009, BEGINNING OCTOBER 1, 2008 AND ENDING SEPTEMBER 30, 2009.**

**WHEREAS**, the City of Neptune Beach adopted an operating budget for fiscal year 2009, and

**WHEREAS**, the nature of budgetary systems and those day to day decisions affecting such budgetary systems requires adjustments from time to time.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF NEPTUNE BEACH, FLORIDA**, that:

1. The Fiscal Year 2009 Final Budget be Amended as follows:

**Description:**

The above revenue amendment is the result of additional receipts of reimbursement from FEMA for Tropical Storm Fay, the decrease in sales and cigarette tax revenues from the State and reimbursements from the construction of the Kings Road Bridge.

The additional expenditures were from the reallocation of workers to the General Fund due to the reduction in Gas Tax receipts from the State.

**Section 2.** The Ordinance shall become effective immediately upon its passage by the City Council.
