CITY MANAGER REPORT

City Manager Andy Hyatt reported the following:

- The Council will now receive the Council meeting agenda packet on tablets. This will help reduce usage of paper and time spent preparing the packet;
- A Home Rule resolution was previously passed on May 1, 2017;
- The City will be converting to the Everbridge Emergency Notification System;
- Demolition of the Girl Scout Building will begin the week of January 16th and preparation of paving of the trail has begun;
- Phase 1 of the Jarboe Master Plan will be discussed at the January 22, 2018, workshop meeting.

COMMENTS FROM THE PUBLIC

Nancy Thomas, 1909 Jarboe Lane, Neptune Beach, thanked the City on behalf of Neptune Beach Elementary School for debris cleanup and fence repair.

VARIANCES/SPECIAL EXCEPTIONS/DEVELOPMENT ORDERS

CDB 17-12, Preliminary Development Permit, Coffee Shop/Dog Park CDB 17-12 / Preliminary Development Permit as outlined in Chapter 27, Article 3 of the Unified Land Development Code of Neptune Beach for Lauren Wyckoff and Jason Underwood for the properties known as 0 Poinciana Rd, 0 Kings Circle S and 0 Florida Blvd. Lots 30 thru 41 Block 1 of Florida Beach Prado Ferrer along with Lot 8 Block 1 of Florida Beach Prado Ferrer (RE# 173272-0000, 173282-0000, 173283-0000, 173285-0000, 173286-0000, 173287-0000, 173288-0000 and 173289-0000).

Mayor Brown explained the applicants are requesting to build a concession style coffee shop bar and dog park along with using a portion of the City's right-of-way for a walking path and this has been approved by the Community Development Board.

Councilor Diamond suggested amending the development permit to include a \$200 per month charge for the City right-of way access.

Vice Mayor Wiley questioned how the \$200 per month charge would compare with the other leases the City has in place.

Councilor Diamond stated that the amount is reasonable for a space that no one else would use.

Councilor Arthur asked if the City right-of-way space is defined in the preliminary development permit.

Deputy City Manager Amanda Askew stated that the area is defined on the site plan.

Mayor Brown questioned if there were regulations regarding the amount charged for leasing the city right-of-way.

Deputy City Manager Askew answered on a sidewalk basis, the charge is \$1.05 per square foot, however, this is a different land use.

Councilor Arthur stated that the \$200 per month amount is representative of the value of the area and land use.

City Attorney Patrick Krechowski advised that the City would be entering into lease agreement and there would be other terms for that agreement. One concern is that it is a different use and there is normally a \$1 million insurance policy. He asked if Council would thrn like to approve the lease agreement as there will be other considerations based on the land use.

Mayor Brown questioned if it should be included that the City be held harmless and make that part of the applicant's insurance.

City Attorney Krechowski answered that there could also be a minimum threshold amount of insurance.

Councilor Diamond suggested giving the City Attorney guidance which includes a minimum threshold of insurance coverage, include Neptune Beach's rider on that insurance, and an indemnity clause for any injuries, etc., in that particular space.

Councilor Arthur stated, and Vice Mayor Wiley agreed, that if terms can be reached that are agreeable to both parties, then there is no need to slow down the process.

The applicants, Jason Underwood and Lauren Wycoff, 2338 Eagles Nest Road, Jacksonville, stated there would be notices in the park and a plan in place for any incidents. Mr. Underwood stated no children would be allowed in the fenced area.

Vice Mayor Wiley stated that during the Community Development Board meeting, the issue of noise and the fence on the east side had been discussed. Mr. Underwood confirmed that those issues have been addressed.
