Call to Order

Mayor Brown called the special meeting to order at 7:12 p.m.

Ordinance No. 2019-03, PUD Moratorium

Ordinance No. 2019-03, Chapter 27, Unified Land Development Regulations, Article IV, Land Use, Section 27-245, Temporary Moratorium First Read and Public Hearing: An Ordinance of the City of Neptune Beach, Florida, Enacting a Temporary Moratorium to Prohibit the Acceptance or Processing of Any Application for a Special Exception Permit, Development Order, or any other Official Action of the City Having the Effect of Permitting or Allowing for the Application of a Planned Unit Development as set forth in Chapter 27, Unified Land Development Regulations, Section 27-244, Planned Unit Development, and Section 27-245, Temporary Moratorium; Providing for a Temporary Moratorium Term to be Extended if Necessary by the City Council; Providing for Early Termination; Providing for Conflicts; Providing for Severability; and Providing an Effective Date

Mayor Brown opened the public hearing.

Mark Scruby, Attorney with Rogers Towers, P.A., 1301 Riverplace Boulevard, Jacksonville, stated he represents Neptune Beach Realty, LLC. He stated that the proposed ordinance, if adopted, would not apply to an any existing PUDs. It would only apply to any subsequent applications after the ordinance is adopted.

There being no further comments, Mayor Brown closed the public hearing.

City Attorney Patrick Krechowski explained that this a go forward ordinance which means anything submitted and deemed complete prior to this ordinance would fall under the rules in existence right now. When and if this ordinance is passed, the moratorium would apply after that.

Councilor Messinger stated that this ordinance is being introduced while the Comprehensive Plan and Code are being rewritten. This is to put a one-year moratorium in place while that process is going on. He added that there is a mechanism in place to extend the moratorium.
