# "Notice of Proposed Tax Increase" Beaches Leader Advertisement

THE FINAL ADOPTION OF THE CITY'S FY-2022 BUDGET UNDERESTIMATED AD-VALOREM (PROPERTY TAXES) BY 2.85%. THE MINIMUM AMOUNT ALLOWED IS 95%. THE PREVIOUSLY ADVERTISED AMOUNT ANTICIPATED ONLY RECEIVING 92.15% OF AD-VALOREM REVENUES. THE CITY IS REQUIRED TO INCREASE THE AMOUNT OF EXPECTED GENERAL FUND REVENUE BY \$94,008. THIS DOESN'T EFFECT THE 3.3656 MILLAGE RATE, OR THE AMOUNT OF PROPERTY THAT RESIDENTS MAY PAY THIS YEAR.

### **FL-DOR REQUIREMENT AND MONTHLY BUDGET AMENDMENTS**

The City received two letters from the Florida Department of Revenue. The first letter was received on 11/19/2021 informing the City that the millage levy process and total taxes levied comply with F.S. §200.065(5). On 11/21/2021 the City received a second letter from the Florida Department of Revenue noting errors violating the Truth in Millage (TRIM) law, that necessitate an amendment to the budget and re-notice.

The language of the readvertised notice was required by the state in its entirety and reads, "The previous notice placed by the City of Neptune Beach has been determined by the Department of Revenue to be in violation of the law, necessitating this second notice." The City published that notice as well as an updated FY-2022 Budget Summary in the Beaches Leader on 12/2/2021.

While the required language is very strong, the reality is that the City is amending the budget to reflect an additional \$94,008 in general fund revenue from ad-valorem (property taxes) than previously advertised. The DOR requirement doesn't affect the 3.3656 millage rate, or the amount of Property Tax that individual Residents may pay this year.

In keeping with best practices for budget management, and new to FY-2022's budget process are monthly budget amendments. The new fiscal year began on October 1, 2021 and already there have been three budget amendments.

All three budget amendments have been due to unanticipated additional revenue - from donations, grants, or the American Rescue Plan Act (ARPA) of 2021. Each Budget Amendment also details which expenditure line item(s) will also be amended.



### Land Development Code Updates



The City's consultants (Dover, Kohl, and Partners) through exceptional community engagement have produced an award-winning *Community Vision Plan* and *Comprehensive Plan*.

In November, with the assistance of the consultants, City Staff began the third phase of the project, the Land Development Code (LDC) Revision. Internally, City staff will work alongside the consultants to review proposed changes to the LDC. Staff begin reviewing edits the week of 12/6, a section at a time.

# Senior Activity Center Updates

A Community Meeting at the site of the new Senior Activity Center was held on 11/29 to discuss plans for exterior finishes of the building. City Staff and the City's consultants, Marquis, Latimer + Halback received critical feedback that will be used to complete a final design.

Residents gave input on color choices, roofing materials, and details for a wraparound porch. Staff also fielded questions about the previous building, the cost of the new building and decisions to construct the new modular building.

Staff anticipates final design and a probable cost of completion to be received by the end of December. The next step will be to publish an RFP based on the probable cost provided by ML+H and competitively select a contractor(s) to finish the exterior of the Senior Activity Center.

The contractor selection process will take approximately one month, putting approval of the contractor(s) on the February 7, 2021 Council Meeting agenda.

Grand Opening of the new Senior Activity Center building is tentatively scheduled for May, 2022.

# How much has this building cost?

The new Senior Activity Center received \$400,000 from the Better Jacksonville ½ cent sales tax to construct the structure that is currently at 2004 Forest Avenue.

# How much will the exterior finishes cost?

ML+H is currently reviewing and incorporating the community feedback received at the Community Meeting. Once that is complete, the City will receive a probable cost of construction to finish the new Senior Activity Center.


### Where did the money come from and where will the money come from to finish the Senior Activity Center?

The City Council approved \$400,000 to come out of the Better Jax ½ cent sales tax. The rest of the funds came from individual donations, grants, and the City of Jacksonville. **BERL+H**

### **Jarboe Park Updates**

# Cost, Completion, & Events

Improvements are nearing completion for Phase I of Jarboe Park. The most commonly asked question about the park is, "when will the courts be open?" Completion of the courts was finished earlier this month, but a safe entrance and exit has not been completed by Public Works Staff, yet.

<u>Good News</u>: the courts are scheduled to be open by the end of December, once the concrete pathway to the entrance of the court complex is poured and cured.

Even though the courts aren't open, visitors have already begun to enjoy the fitness equipment, playgrounds and even the field next to the Neptune House. The City has hosted four different events throughout November and December and has more planned in the Spring.

During the Safe Streets Summit on 11/4, City officials had the East Coast Greenway Ribbon-cutting for a section of trail through Jarboe Park, adding even more to the City's trail network.

For the first time since 2019, Movies with the Mayor took place on 11/19 at the lawn near the westside of the Neptune House. Once the sun had set, the hundreds of families that were around the various amenities at the park huddled on the lawn with hot cocoa to watch E.T. Thank you to the Beaches Town Center for providing refreshments. Residents also enjoyed an online auction to benefit the Neptune Beach Elementary sponsored by the PTA.

November 20<sup>th</sup> was the rescheduled 90<sup>th</sup> Anniversary Celebration at Jarboe Park. The City honored longtenured Residents, including Nancy Jensen, Pete Jensen's granddaughter (the original founder/owner of Pete's Bar), and the grandchildren of Mayor O.O. McCollum, the first Mayor of Neptune Beach.



On Nov. 4, elected officials, and state and local partners, cut the ribbon for the final segment of the East Coast Greenway through the city of Neptune Beach. In addition to users of the Greenway's 3,000-mile route from Canada to Key West, a high number of local walkers, runners and cyclists are anticipated to use this corridor to sustainably travel from their homes to Neptune Beach's schools, parks, commercial district and beach.




### East Coast Greenway (Jarboe Park)
