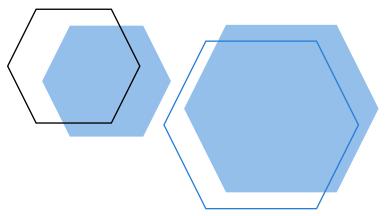


### **JARBOE PARK UPDATES**

### COST-TRACKING AND PROJECT REPORT

Construction for Phase I improvements at the park are quickly coming to an end. Two playgrounds have been installed with sunshades and seating areas. New concrete paths and asphalt trails have been constructed, tying nearly an additional three-quarters of a mile into the City's already complete East Coast Greenway. Eight pickleball courts, two tennis courts, two volleyball courts, and a junior basketball court have been added, complete with new fencing, striping, and lighting.

The City continues to add concrete paths throughout the park and will begin finish work in November. The main entrance to the park at 5<sup>th</sup> Street will be completed before 90<sup>th</sup> Anniversary Events begin on 11/19 and 11/20. Two new sunshades will be installed at the Southern end of the Volleyball Courts and Tennis Courts. Finish work items include additional grass seeding at various locations throughout the park, constructing an architectural fence around the HVAC units attached to the Neptune House, and landscaping.



### **JARBOE PARK COST**

### COST-TRACKING SPREADSHEET AND PUBLIC WORKS COSTS

Phase 1 of improvements to Jarboe Park included an original budget of \$1,243,088.00. Over the course of the project, two change orders were approved by the Council – one change order for ACON (the sitework and trails contractor) in the amount of \$41,812.50 and another for Kompan (the playground equipment) in the amount of \$55,850.78, bringing the total approved budget for Phase I improvements to \$1,340,751.28.

With construction winding down on Phase I, the City has spent \$1,201,711.46 towards improvements. The total remaining budget for improvements on Phase I is \$112,800.65, of which \$86,656.54 is currently earmarked for completing the new courts. Currently, the total for Phase I improvements is anticipated to be under budget by \$57.00, and assumes that all open purchase authorizations and budgeted items are completely exhausted.

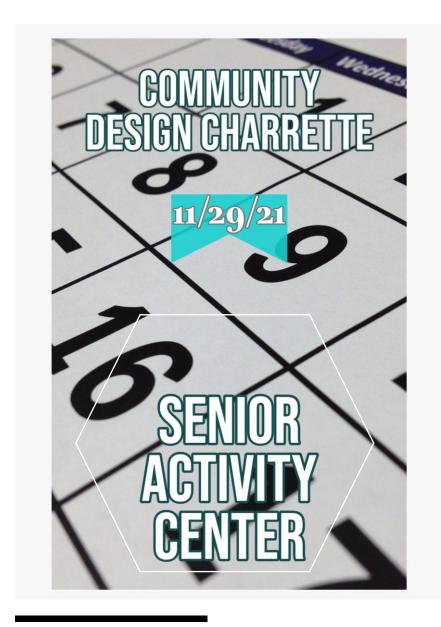

### NEPTUNE BEACH SENIOR ACTIVITY CENTER

### **EXTERIOR DESIGN + COMMUNITY MEETING**

Marquis, Latimer + Halback hosted Leslie Lyne and Stefen Wynn on October 20<sup>th</sup> at their office in Saint Augustine. Mr. Marquis and the staff architect showed a couple of conceptual drawings that married together all of the requirements for the site, including a wrap-around front porch, parking, stormwater and architectural roof line.

The Team discussed an onsite meeting with residents, stakeholders and the community, and settled on November 29<sup>th</sup> at 5:30PM. ML+H will meet with the community in the front lawn of the NBSAC to discuss their conceptual drawings and gather community feedback. Please join us and come prepared to offer your ideas!

ML+H has until December to get completed drawings to the City. Shortly after drawings are received, permitting with SJRWMD will begin, and the RFP process for contractors will follow. Most likely, construction on exterior improvements will begin in early-February.

### **NBSAC AVAILABLE CONSTRUCTION FUNDS**

### **FUNDRAISING & BUDGETING**

The City of Jacksonville approved \$75,000.00 towards the final construction of Senior Activity Center during their May 2021 Council meeting. Eligible activities included the final connection for HVAC relocation work, Design & Permitting of the Parking Lot and Landscape Area, and Architectural Rendering, Materials, and Labor for the Front Porch construction. Staff will submit a reimbursement request the week of 11/1 to the City of Jacksonville for completed eligible activities.

Leslie Lyne attended the Atlantic Beach Council Meeting on 10/25 and received a \$2,000 donation check from the City of Atlantic Beach. The City of Neptune Beach is very grateful for the continued support of its sister city in Atlantic Beach and we can't wait until the Senior Center is open and can once again serve all beaches residents.

Final design from ML+H is expected to cost approximately \$36,000.00. Leslie Lyne was very successful in raising funds throughout the pandemic and last year. After the anticipated expense for final design and permitting, the donation balance for construction will be approximately \$154,000. Staff will submit a final plan and budget for construction as a part of the RFP process to select a contractor.



### **ROAD CLOSURES**

### PENMAN ROAD CLOSING EAST OF PENMAN AND WEST OF 3RD ON 11/8

Progress is coming. Since 2017, the City has planned, designed, and funded a project that will have a profound impact on stormwater drainage for most of the City. The Florida Boulevard Culvert replacement project is scheduled to begin on November 8<sup>th</sup>, and will require an extended road closure. Beginning on Monday, November 1<sup>st</sup> a, 'soft-closure' will be in effect – no work will be performed but the intersection will be closed. This is so that normal commuters get used to the road being closed and use either Atlantic Boulevard or Penman Road to get to the Mayport Flyover and Atlantic Boulevard Bridge. On November 8<sup>th</sup> work will promptly begin on the culvert and the intersection at 5<sup>th</sup> Street and Florida Boulevard will be closed throughout the duration of the project (anticipated reopening in May).

On Saturday, October 30<sup>th</sup>, Florida Boulevard was closed between Penman Road and Atlantic Boulevard while Sprint removed cellular equipment from the City's Water Tower. This is the last cellular provider to remove their equipment from the water tower and their new parent company T-Mobile plans to demolish and remove existing ground equipment shortly after. Once Sprint and T-Mobile are finished then the City can begin repair and maintenance on the water tower. America Rescue Plan Act funding is going to be used to sandblast the water tower so that a new coating can be applied. Enterprise funding has also been programmed into the FY-22 budget to pay for repairs to the corral and other areas on the water tower.

### WASTEWATER EMERGENCY REPAIRS

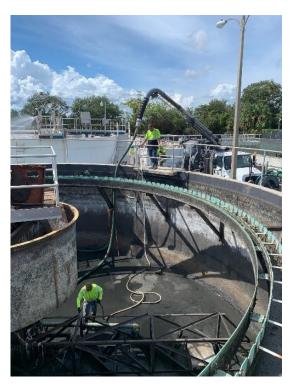
The wastewater department has available positions and due to the vacancies, they're understaffed. To assist with meeting the labor demand shortages, JEA has sent temporary assistance including a wastewater operator and pump mechanic. JEA CEO Jay Stowe has been a phenomenal partner and the City thanks him and JEA for their assistance.

October proved to be a dramatic month for existing sanitary sewer infrastructure. A sinkhole was found at the intersection of Forest Avenue and Strickland Road, another found at the manhole at the intersection of Strickland Road and Seagull Cove, and another sinkhole found near 1626 and 1630 Arrowhead Trail. Due to the volume of issues and that one of the identified lines is the main gravity feed to a large section of the city into the Wastewater Treatment Facility, a limited emergency was declared allowing §2-377 (1) of the City's code to be activated – Automatic Granting for Emergency Purchases.

**Budget Transfer 2022-03 Request for Sewer Transfers** was created to identify fund accounts for transfer into the Repair and Maintenance fund for sewer (<u>ATTACHMENT B</u>). Transfers from within Sewer Services are scheduled to be made the week of 11/1 to increase 401-4335-535-30-46 Repair and Maintenance to cover the cost. Budget transfers within the same fund are allowed to be done by the City Manager without council approval under §2-363 as long as the transfer doesn't exceed the total appropriation for the fund.

JEA assisted the City and Gruhn May with a remote-controlled camera to televise the sewer mains on Forest Avenue and Strickland Road to help identify the exact locations of damage. The clay pipe had already been relined and was still failing. Because the pipe had already been relined, this section of sewer main is a good candidate for pipe-bursting.





### **PUBLIC WORKS**

### WASTEWATER TREATMENT FACILITY REPAIR & MAINTENANCE

The FY-22 Budget has funding programmed to repair neglected appurtenances of the wastewater treatment facility. Early in October, the clarifier in the WWTF went down and a contractor (Ovivo) was called to replace the drive mechanism. Prior to completing the work, staff in Wastewater and staff from Distribution and Collections took the opportunity to clean the clarifier.

Repair was also completed on the clarifier arm that had been repaired over five years ago (with zip ties and twine), this time with welded aluminum. After the clarifier pumps were installed, a deficiency was discovered within the rubber seals and stiffener – new rubber has been ordered and staff fabricated a new stiffener.

While cleaning the clarifier, crews also noticed a clog in the clarifier drain line and took the opportunity to clean and unclog the line.



### **PUBLIC WORKS**

### STORM WATER, WATER PLANT & STREETS

On October 8<sup>th</sup>, Stormwater crews responded to many issues caused by heavy rains. Approximately 2" of rainwater fell between 12:20 and 3:00 PM. Public Works began a spreadsheet to help track areas of the City with slow draining storm systems, standing water, or serious flooding. Capturing this data will assist in budgeting and planning improvements for stormwater in subsequent budget years.

The stormwater division also installed new pipe on the Northeast corner of Poinciana Road to improve drainage in that localized area. While installing pipe, crews also pumped the Poinciana Road ditch to decrease the level of water retained within it.

Stormwater crews also completed ditch work to improve drainage along Bay Road and Marsh Point Road, including the installation of a culvert.

In order to complete a wider sidewalk to the Bay Street entrance of the Butterfly Garden, the Stormwater Division installed a larger culvert at Jarboe Park between the ponds.



### **PUBLIC WORKS**

### STORM WATER, WATER PLANT & STREETS

Items for improvement as identified in the FDEP's recent sanitary survey for the Water Services Division have begun to be completed throughout the City's Drinking Water plant and distribution network. One of the wells were noted to be in need of repairs, and the water department scaled and repainted it. Another item noted to be in need of repair was with the City's Tray Aerator, and the Water Division completed maintenance on the aerator at the Water Plant.

The Water Department also assisted with repairs at the Emma Lane Lift-station and removed rags clogging the pump. While the pump was removed from the lift-station an inspection was conducted that showed there is significant wear on the impeller and wear ring, and further repair and maintenance will be required.

The Streets Division had a very busy month with removing a tree that fell within the right of way at 5<sup>th</sup> and Pine Streets, assisting other divisions with emergency repairs due to sink holes, and continuing their phenomenal work in Jarboe Park and the Butterfly Garden. The Streets Division will continue to form and pour concrete through the first couple weeks of November to get the entrance to Jarboe Park ready for the 90<sup>th</sup> Anniversary Celebration.



### **CONTRACTORS SELECTED**

### GENERAL ENGINEERING CONTINUING CONTRACT AWAREDED TO FOUR FIRMS

On October 4<sup>th</sup>, the City Council approved the recommendation of the selections committee to award contracts to four firms for General Engineering Continuing Services. Dewberry Engineers, Inc., Jones Edmunds & Associates, inc., Ardurra Group, inc., and Kimley-Horn and Associates, inc. The City plans to use these contracts for a number of upcoming projects, and may even allow building permit applicants that wish for an expedited review of their plans to use one of the four third-party engineers to complete the review.

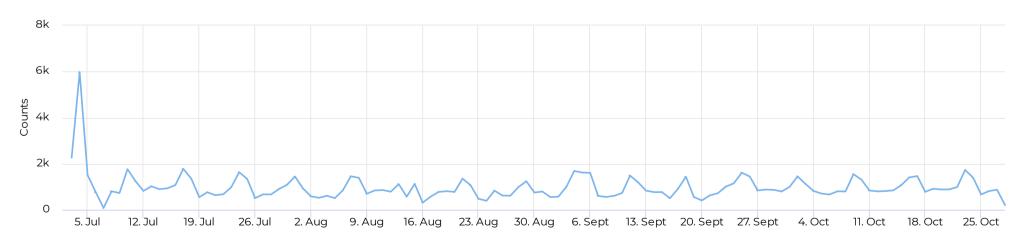
