Week of April 4, 2022:

• D&C repaired a water break that was inside a stormwater structure at First and Margaret Streets.






- Attend meeting with the City's Consultant to review draft water projections for the CUP renewal.
- Streets moved the fence in Jarboe Park to open up the sidewalk to 5th Street.
- Parks mowed the pond and R-O-W at First Street and Florida Blvd.



• Stormwater replaced a leaking hydraulic piston on the street sweeper.



• Stormwater cleaned catch basins around the City to remove accumulated debris and promote drainage.



• Stormwater temporarily pulled the gutter protection at 3rd and Lemons Street on the FDOT's project so the water would drain out of the travel way in the best interest of the public's safety. We followed up with an email to the FDOT requesting that their Contractor inspect the erosion and sediment BMPs on the project.





- D&C televised the sewer lateral at 409 Driftwood to check for any issues to assist the resident and found none.
- Wastewater worked on needed repairs to the WWTF influent lift station. During the repair efforts staff identified additional critical items for repair including: the shaft to Influent valve on pump #2 needs repair and the valve is not operational, the check valve and isolation valve to pump #1 has

accumulated grit preventing operation and needs to be cleaned, and the packing gland on pump #3 needs replacing. Staff is scheduling additional work.


- D&C worked on work orders including meter change outs, turns and tun offs, curb stop changes, etc.

Week of April 11:

- Wastewater collecting toxicity samples and taking them to the lab in Gainesville.
- Wastewater made temporary repairs to the air duct header on Plant 2.

- D&C worked on work orders including meter change outs, turns and tun offs, curb stop changes, etc.
- D&C worked on locate tickets.
- The Water Department coordinated with Beaches Energy to temporarily remove existing light poles in the way of the upcoming water tower renovations.





- D&C started raising meter boxes on Midway.
- Streets installed Lance McAlister memorial signs on First Street.
- The Streets Department worked on extending the beach end street markers.

Week of April 18:

- D&C worked on work orders including meter change outs, turns and tun offs, curb stop changes, etc.
- D&C worked on locate tickets.
- Attend pre-application meeting with the SJRWMD for the Consumptive Use Permit renewal.
- Attend monthly progress meeting for the Florida Blvd. Culvert Replacement project.
- Worked with the Contractor at 5th and Florida Blvd to alleviate stormwater staged upstream.





- The Streets Department removed a tree at 505 McCullum Circle.
- The Streets Department trimmed brush on the south side of Florida Blvd from the elementary school to the 5-way intersection.
- The Streets Department patched 10-tons of asphalt on Forest Ave., Indian Woods, Starbucks entrance, and First St. from recent utility work.
- D&C attempted to help a resident find a ring that was flushed down a toilet by running a camera up the sewer lateral.
- D&C helped Atlantic Beach by going up to Sailfish and running a sewer later with our vacuum truck to remove a clog. Atlantic Beach's vacuum truck was down for repairs.
- Stormwater prepared and printed the annual newsletter to send out with the City's May utility's bills to provide public education as required with the City's MS4 permit.
- The Parks Department started work on an interior build-out at City Hall to split a large office space into two offices.



• Stormwater mowed with the boom mower.



• The Streets Department cleared sand off the Hopkins Street dune crossover.









• The Water Department re-ragged the pump impellers at the Bay Street lift station to keep the lift station functioning.



- The Water Department coordinated to have a bad phase monitor replaced for high service pump #2 at the water treatment plant.
- The Water Department coordinated to have a bad pump alternator replaced at the Oceanwood lift station.

Week of April 25:

- The Streets Department attempted to cut down a tree at the water tower needed for the water tower renovation. While working on the tree one of our staff was severely hurt and was rushed to the hospital.
- D&C worked on work orders including meter change outs, turns and tun offs, curb stop changes, etc.
- D&C worked on locate tickets.
- D&C worked with the Contractor at 5th and Florida Blvd to reroute the sewer forcemain over the new culvert.
- Attend monthly BMAP TAT meeting.
- D&C repaired a water break on Indian Woods Drive.
- Stormwater mowed ditch banks.
- Gruhn and May working on installing the new water main in Indian Woods.
- The Streets Department installed missing sections of dune protection rope in preparation of Turtle season starting in May.
- The Streets Department cleared sand off the Hopkins Street dune crossover.
- The Streets Department mowing around the City.

• D&C worked with the Contractor at the Florida Blvd. Culvert Replacement project to flush new water lines.



• The Streets Department painted crosswalks along the Florida Blvd.



• D&C and the Water Department worked with the Contractor on the Florida Blvd. Culvert Replacement Project to change over to the new forcemain.

Week of February 28:

• D&C continued cleaning up the construction area, removing the temporary bypass pumping system, removing barricades and signage, and worked on site restorations after the pipe bursting sewer work on Forest Avenue.

Beach Tilling and Grading to Begin February 28th

Project to run through March 2nd POSTED ON: FEBRUARY 15, 2022 - 3:11PM

As part of Duval County's Beach Renourishment Program, beach tilling and grading will begin on Monday, February 28th and run to Wednesday, March 2nd. The beach tilling will create a leveled, even surface with no ruts for the entire beach surface from the wave uprush line, to 10' from the toe of the dune slope. A safety representative will be on an ATV ahead of the tilling machine- asking beachgoers to temporarily relocate, until the machine passes by. Work will commence rain or shine.



• The Parks Department met with Colin Moore and checked the programming of lights for the courts at Jarboe Park. The off sequence had been deleted from the programming so the lights would stay on all night. A zip tie was added around the control box to visually see when the control box is entered.



Week of March 7:

• D&C replaced a manhole ring and cover on the gravity sewer main into the WWTF.



- D&C worked on work orders including meter change outs, turns and tun offs, curb stop changes, etc.

• Wastewater replaced the out of service RAS meter at the WWTF.




- Streets poured concrete in Jarboe Park.
